## Sunnycot, Bailes Lane, Normandy.

**Owner/occupiers - Ann and Richard Woods.** 

Ann and Richard have kindly permitted copies of the following documents to be placed in the archives of Normandy Historians:

- (a) Abstract of the Title of the personal representatives of Mr William Deedman to a cottage and garden land situate at Normandy in the Parish of Worplesdon in the County of Surrey, dated 1928.
- (b) Conveyance dated 17th August 1928 of the above cottage and garden by the personal representatives of Mr William Deedman to Miss M K Thorp.
- (c) Conveyance dated 29th March 1949 of "Sunnycot", Willey Green, Normandy by Miss Minnie Kate Thorp to Mrs Edith Jane Woods.
- (d) Mortgage Agreement dated 29th March 1949 between Mrs E J Woods to Miss W Lewis and Mrs Jessica Evershed (widow).
- (e) H M Land Registry title dated 6th December 1971 regarding transfer of "Sunnycot" from Edith Jane Woods to Jonathan Martin Meaney and Carmel Ann Meaney. Epitome of Title dated 1971 of E J Woods (deceased) to "Sunnyco".

In 1971 Richard purchased "Sunnycot" from Mr and Mrs Meaney. What follows are the salient features extracted from the Abstract of Title:

- 1. By an Indenture dated 24th December 1859, G White and William Jones conveyed to J Stedman and G Stedman that parcel of land being part of a field called Brown's Field.
- 2. By an Indenture dated 12th October 1861, John Stedman the Elder of Wood Street in the Parish of Worp!esdon, Surrey, Gentleman, conveyed to Thomas Deedman of Worplesdon, Sawyer, for the sum of £23, that parcel of land shown on plan A, being at Normandy in Worplesdon, Surrey and being part of a field called Brown's Field, with a frontage of 50 feet and a depth of 150 feet as shown shaded green.
- 3. By an Indenture dated 12th October 1861, William Jones of Chobbam, Surrey, Licensed Victualler, conveyed to Thomas Deedman for £35 that parcel of land on plan B being at Normandy in the Parish of Worpledson Surrey and being part of a field called Brown's Field.
- 4. By his Will dated 26th January 1909, Thomas Deedman appointed his son William Deedman sole Trustee and Testator
- 5. Thomas Deedman died 2nd February 1909 and his Will proved 30 April 1909.
- 6. By an Indenture of Mortgage dated 20th July 1909, William Deedman of Normandy in Surrey, Farmer (mortgagor) and Gordon Gray Tompsett of Farnham, Surrey (mortgagee), lent £750 to William Deeedman for 6 months with interest at 4.5% pa.
- 7. As Trustee, William under the terms of the Will inherited the 10 cottages, then erected on the land, together with an adjoining parcel of land. The land edged pink on plan C was conveyed to Thomas Deadman or Deedman by Indentures dated 19th August 1854, 12th October 1861 and 2nd January 1869.
- 8. On 29th July 1909 William Deedman as Trustee and in accord with the terms of the Will paid £125 to Thomas's daughter, Mrs John Freeland and to each of the following £5: Thomas's brother Jesse, Mary Bonner, Louisa Cotterell, Emily Deedman, Sarah Jerome, Kate Lee and Mrs J Clinker.
- 9. By his Will dated 3rd February 1926, William Deedman appointed his daughter Emily Jane Deedman and his brother-in-law Thomas Osgood to be Executrix and Executor.
- 10. William Deedman died 18th December 1927 and his Will proved 20th April 1928.
