## Part 2: Willey Green, West End tithing, parish of Worplesdon - plots 1064 to 1158.

### 1064 - 1075. Whibley Farm.

Freehold of the manor of Worplesdon, annual rent 10s 8d. [SHC G97/6/26]

Including plot 1070, Whibley Copse (see below).

- 15<sup>th</sup> century Whibley Farm was probably established and the central part of the house was built. [MSS153 page 5, Dr West]
- 1547-49 Apparently held by Thomas Clifton. [Harley roll]
- 1599-1603 Owned by George Clifton. [TS19]
- 1655 Owned/occupied by John Clifton. [Worplesdon PR]
- 1659 John Clifton, farmer, died. [Worplesdon PR]
- 1669 Apparently owned by Henry Clifton. [SHC 212/117/30-32]
- 1680 Henry Clifton of Whibley, gentleman, mortgaged lands in Worplesdon and Ash for £500. [SHC 212/117/37]
- 1737 The south wing was built, in Georgian style. [JVS]
- 1757 Note - exemplification of common recovery - Henry Stevens and Henry Stevens his son, for 215 acres in Worplesdon and Ash. [SHC 212/117/42]
- 1762-70 Owned by Richard then John Stevens. [SHC G97/6/9]
- 1774/75 Probably Stevens sold to William Bray Esq. [TS19 - see plot 644]
- 1774/75 Probably William Bray sold to Solomon Dayrolles of Henley Park. [TS19]
- 1781-91 Owned by Solomon Dayrolles, occupied by John Compton, rent £71. [land tax]
- 1784 Apparently sold by Solomon Dayrolles to Henry Halsey, with Henley Park.
- 1787 Owned by Henry Halsey. [SHC G97/6/9]
- 1792-1824 Owned by Halsey, occupied by Robert Dover, rent £71. [land tax]
- 1825-31 Owned by Halsey, occupied by William Collins, rent £71. [land tax]
- 1838 152 acres, owned by HWRW Halsey, occupied by William Collins. [tithe]
- 1851 Occ. by Henry Collins, farmer of 183 acres employing 13 labourers. [census]
- 1861 Occupied by Henry Collins, farmer employing 14 labourers, 6 boys and 2 women. [census]
- 1871 Occupied by Henry Collins, farmer of 250 acres employing 17 men and 4 boys. [census]
- 1867-82 Occupied by Henry Collins, farmer. [directory]
- 1879 Henry Collins of Whibley farm died 4 Feb. Bequeathed his estate to George Fladgate of Henley Park Farm and sons John and James Collins, executors, on trust. George Fladgate subsequently renounced the trust. [MSS200]
- 1879 The Halseys leased to John Collins for 14 years. [SHC ref. 1794]
- 1881 Occupied by John Collins, farmer of 192 acres, age 29. [census]
- 1882-85 192 acres occupied by John Collins, rent £140. [SHC ref. 1794]
- 1887-95 Occupied by John Collins, farmer. [directory]
- 1891 Probably occupied by Albert Collins, farmer age 28. [census]
- c.1891 190 acres, occupied by Mr Albert Collins. [SHC ref. 1794]

- 1895 The Halseys purchased a piece of land from Edward Chitty. [PW85]  
 1899-1907 Occupied by Albert Collins, farmer. [directory]  
 Between 1838 and 1922 (probably 1891 to 1910), four fields, 24 acres, were transferred from Whibley Farm to Bailes Farm (both owned by the Halseys). [tithe, PW85]  
 1909-19 Occupied by Alfred James Lewry, farmer. [directory]  
 c.1910 Owned by Halsey, occupied by AJ Sewry, 175 acres, rent £155, gross value £4,260. [value 317]  
 1922 Lot 10 in the Henley Park estate sale; a very productive corn and stock farm occupied by Isaac Bolton on 2 years' notice, rent £134, 143 acres (including 4 acres of pasture and a cottage in Normandy, and Clasford coppice below and 36 acres of pasture, part of Lot 1). [PW85]  
 June 1922 It did not reach its reserve price of £3,250 at auction. [County Times 10/6/1922]  
 1922-24 Occupied by Isaac Bolton, farmer. [directory]  
 1925 Apparently sold by HJT Halsey to E Ramsay Moodie, with Henley Park.  
 1930 Occupied by William and Kitty Cook and Ella Cadle. [Elect Reg]  
 1934 Occupied by George Dykes. [rate book]  
 c.1935 Purchased by FR Hawkins (apparently from Ramsay Moodie). [MSS118]  
 1938 Farmed by Mr Hawkins. [PW25]  
 c.1941 Owned and occupied by FR Hawkins for 6½years. 84 acres + 40 acres grazing, rent £118. [MSS118]  
 c.1944 The Hawkins' left and returned to Devon. [Dr. West]  
 c.1942? Late FR Hawkins, now occupied by H Baldrey, 124 acres, rent £118. [national farming survey, PRO ref MAF32]  
 1949 Occupied by John H, Henry W and Keith Baldrey. [elect reg]  
 1940s/50s Owned by Mr Billmeir, who modernised the house. [Dr. West]  
 1970s The house, farm buildings and woodland were owned by Mr Porter, a builder. The rest of the farm land was owned separately (by Guildford Borough Council) and was taken over and farmed by Merrist Wood. [Dr. West]  
 Mid-1970s The Wests bought the house from Mr Porter. [Dr. West]

**1070. Whibley Copse, 14 acres. Also 780 Clasford Copse, 3 acres.**

- 1838 Owned and occupied by HWRW Halsey. [tithe]  
 c.1910 Woodland in hand, owned and occupied by Halsey. Gross value including Clasford Coppice £440, rent including Clasford Coppice £3 10/- [value 229]  
 1922 Both part of lot 10, Whibley Farm, in the Henley Park estate sale. Whibley Copse had well-grown oak timber. [PW85]

**780. Clasford Copse.**

- c.1929 'The Bungalow' built on site. Owned by ER Moodie, occupied by Walter Nelson Clark. [elect reg]  
 1934 'Petit Tor' owned by ER Moodie, occupied by James Stephenson. [rate book]  
 1949 'The Bungalow' occupied by Walter G Andrews, 'The Cottage' occupied by Harry Marney. [elect reg]  
 1964 'Clasford Copse Bungalow' occupied by Joseph F Francis, 'Little Whibley' occupied by Arthur E Carman. [elect reg]

**1076 - 1080. Chapel Farm, Willey Green.**

Including plot 1079 Normandy Chapel and 1080, Dairyhead, until 1750 then see below.

- 4/5/1352 John Fletcher and Joan his wife, Philip of Beckford and Julian his wife and E? sister of the foresaid Julian, granted a plot of land called Heathers in Henley near Guildford to king Edward III. [close rolls]
- 8/5/1352 The king granted Heathers to John Aynolf in exchange for a toft inside Henley Park. [close rolls]
- c.1488 John Bedell had a tenement called Le Derhond, rent 14s.

Described in Cleygate Manor records as:

Freehold tenement and land called Hethers in Worplesdon, rent 1s, held by the 1352 letters patent. Also a freehold croft and meadow lying to the east of the park of Henley (or described as one croft of land in an orchard being part of the park of Henley) called Dairycroft, containing 1 acre, rent 1s 2d.

- by 1532 Henry Bedill died, property descended to his son John Bedill.
- 1547-49 Held by John Bedell. [Harley roll]
- c.1580 Held by John Bedill. [TS19/19]
- by 1594 John Bedell died, property descended to John Bedell of full age, the son of Robert Bedell brother of John Bedell.
- by 1597 John Bedell sold to Richard Bromefield.
- 1599-1603 Owned by Richard Broomfield.
- 1607 The gate in Henley Park near Willey Green was called Bedell's Gate, and just inside the park was Bedell's Oak. [Norden]

Subsequently described as: Heathers alias Beadles (or or Bedells or Bedlers) alias Hettricks (or Hettbucks), freehold messuage and 7 acres of land, rent 2s 2d then 2s 6d.

- 1620 rental: Held by Richard Broomfield (with Hill Inhams & the Old Homestead).
- 1638 Anthony Gadd was recognised as the holder.
- [1649-64] Anthony Gadd died, descended to his relative Joan Gadd.
- 1668 'Lately Bedles'.
- 1668 rental: Held by Joan, wife of Thomas Draper.
- 1669 Apparently owned by Thomas Draper, occupied by John Callingham. [SHC 212/117/30-32]
- [1668-82] Thomas Draper and Joan his wife sold to Henry Clifton, gent.
- 1680 Messuage, barns, outhouses, buildings, gardens, orchards, yards & backsides and four closes of land, 8 acres, owned by Henry Clifton, occupied by Richard Jennance; mortgaged with other lands by Henry Clifton. [SHC 212/117/37]
- [1682-85] Henry Clifton sold to Mrs Jewer, widow.
- 1697 rental: Held by Henry Clifton. Subsequently annotated 'John Westbrooke himself'.
- 1697 rental: Also held by Jewer, widow. (Apparently these two relate to the same property)
- [1715-16] John Westbrooke died, bequeathed to his son James Westbrooke, heriot one bullock.
- 1722 rental: Held by James Westbrook.
- [1722-31] James Westbrook died, Rebecca his wife in possession.
- [before 1750] Owned by John Westbrooke (including Dairyhead, plot 1080).
- [1746-50] John Westbrooke sold Dairyhead to Solomon Dayrolle Esq (see 1080 below).

The remainder subsequently described in Cleygate Manor records as:

Part of messuage and 7 acres, apportioned part of rent 1s 6d.

- [1746-50] John Westbrook sold to John Martin (1) of Broadstreet in Worplesdon.
- [1759-64] John Martin of Broadstreet died, descended to eldest son John Martin. (2)
- [1768-74] John Martin of Broadstreet died, descended to eldest son John Martin. (3)
- c.1780 "John Martins house near Phillips Christmass", entitled to cut two loads of peat from Cleygate peat moor. [TS19/40]
- [1775-82] John Martin died.
- 1780-81 House and land, owned by heirs of John Martin, occupied by Mrs Martin then James Hirst, rent £4. [land tax]
- 1782 Henry Martin, son and heir of John Martin, sold to William Bicknell.
- 1782-87 Owned by William Bicknell, occupied by James Potter. [land tax]
- 1788 William Bicknell died age 46, descended to son John Bicknell (age 17 in 1790). [Worplesdon PR, Cleygate manor roll]
- 1788-93 Owned by heirs of William Bicknell, occupied by James Potter. [land tax]
- 1790 rental: Held by John Bicknell. [212/4/24]
- 1796 Owned and occupied by John Bicknell. [land tax]
- [1794-97] John Bicknell sold to William Attfield.
- 1798-1814 Owned and occupied by William Attfield Junior. [land tax]
- c.1818 Owned by Mr Attfield, occupied by Henry Barrett, entitled to cut two loads of peat from Cleygate peat moor. [TS19/40]
- 1815-27 Owned by William Attfield, occupied by Henry Glover. [land tax]
- 1825 rental: Held by William Attfield.
- 1830/31 William Attfield died, willed property to nephew Henry Attfield.
- 1829-31 Owned by Henry Attfield, occupied by Henry Glover. [land tax]
- By 1841 plot 1079 was sold or donated for Normandy Chapel, see below. [tithe]
- 1841 Owned by Henry Attfield, occupied by James Davey. Now comprises plots 1076-1078, 5-3-9. Plot 1078 is cottage and garden. [tithe]
- 1841 Occupied by James Davey, farmer of 5 acres, with George Lovelock and Henry Glover. [census]
- [1841-51] Henry Attfield sold to Mr Burrell of Frimley.
- 1851 Occupied by William Bridger, ag lab, and Henry Glover. [census]
- 1861 Occupied by William Bridger, shepherd and William Wheeler. [census]
- 1861-71 'Elm Cottage' occupied by Daniel Deedman, sawyer. [census]
- 1869 indenture: Held by Mr Burrell. [G97/11/15]
- 1871 Occupied by William Bridger, retired. [census]
- [1874-85] Rev Henry Shrubbs died, property descended to his nephew Charles Peytoe Shrubbs Esq.
- Note: Charles Peto Shrubbs built Merrist Wood house in 1877. [JVS]
- 1891-1901 'Elm Cottage' occupied by George South, ag lab. [census]
- 1899 Held freehold by Charles Peytoe Shrubbs; he died.
- c.1910 Chapel Farm, owned by Hewett & Lee of Guildford, occupied by J Smith. [value Worp 402]
- Probably 1912 Hewett & Lee sold to HD Arbuthnot. (See Cobbetts Hill)
- 21/10/1919 HM Principal Secretary to Harold Denison Arbuthnot of Merrist Wood; enfranchised (with Clements, Cobbetts Hill) for £136 0s 10d.
- 1922 Purchased by Charles Hellard, a retired Army Captain. He renamed it 'Chapel Farm' in reference to the nearby Congregational Chapel. [Jack Kinder]
- They kept pigs until June 1926 when swine fever struck and they lost their livelihood. [Jack Kinder]

- 1929 Plot 1077: A residential property called 'Penrhyn Bungalow' was built for Charles and Alice Hellard of Chapel Farm. [elect reg]
- 1930 Occupied by Charles and Alice Hellard. [Elect Reg]
- 1934 Penrhyn Bungalow occupied by Mrs T Tillman. [rate book]
- 1936 March Mr Hellard sold 'Elm Cottage' to David Bayliss. [rate book]
- 1936 Chapel Farm was a 5-acre smallholding. Charles Hellard sold it to the Bayliss family, timber merchants from West End, Woking. [PW140, MSS6/10]
- 1938 William Bayliss, second hand car dealer. [directory]
- 1940s During the war they broke up cars to provide metal - this was the origin of the scrapyard. The woodyard was also started during the war. They used to hold gymkhanas in the field behind. [MSS6/10]
- In 1965 Normandy Auto Salvage started trading. [PW74]
- 1966-70 W. Bayliss, garden sheds and fencing. Tel Normandy 3120. [PW70, PW28]
- 1981-82 W. Bayliss & sons, Chapel Farm. Wendy houses, fencing, loose boxes, summerhouses, timber, logs and firewood. [PW74]
- 1981-82 AG Bayliss, Normandy Auto Salvage, Chapel Farm. Managed by John Norgate. Tel 3343/235675. Salvage and spares. Mon-Sat 9-6, Sun till 1.30. [PW74]
- 1992/93 The woodyard closed. [JVS]
- 1994 June The farm shop opened. [JVS]
- In 1998 The farm shop closed. [JVS]

### **1079. Normandy Chapel.**

- Originally part of Heathers otherwise Beadles (see plot 1076 above).
- By 1825 The chapel was established and flourishing. [PTB]
- 1841 Shown as Normandy Chapel. [tithe]

**1080. Dairy Mead**, a freehold meadow at Willey Green.

1550-94 1 acre, “part of the Park of Henley” or “to the east of the Park of Henley”, rent 14d; with Heathers otherwise Beadles (above). [MSS182/3]

Up to 1750 Part of Heathers otherwise Beadles (see plot 1076 above).  
Then described in the Cleygate Manor records as: A freehold mead, parcel of Heathers otherwise Beadles, rent 1s. Situation: in Whibley Lane on the left hand. [TS19/49]

[1746-1750] John Westbrooke sold to Solomon Dayrolle Esq. Apportioned rent 1s.  
[1782-86] Solomon Dayrolle Esq sold to Henry Halsey Esq.  
1781-1804 Occupied by William Chitty (with Henley Park farm), rent £ 1. [land tax]  
1790 rental: Held by Henry Halsey. [212/4/24]  
1807 Occupied by William Chitty (with Henley Park Farm).  
1805-13 Occupied by Joseph Davies, rent £ 1. [land tax]  
1814-29 Occupied by Thomas Woods, rent £ 1. [land tax]  
1825 rental: Held by trustees of HWRW Halsey.  
1830-31 Land, occupied by Thomas Boyer, rent £ 1. [land tax]  
1841 Owned by HWRW Halsey, occupied by William Faggotter. 2-0-23 [tithe]  
[1830s?] Occupied by William Faggotter. [TS19/49]  
[1850s?] Annotated ‘James Fladgate’s little meadow now arable’. [TS19/49]  
c.1910 Part of Henley Park Farm, occupied by O Christmas. [value 111]  
1922 Part of Lot 1, Henley Park Farm, in Henley Park estate sale. [sale]

**1082 - 1088. The Old Homestead and Chandlers Field, Willey Green.**

Described as: A parcel of land called Pursses [probably a mistake, see Tickners 1110. JVS] by 1526 John Whitefield sold to William Hamond of Guildford.

Then described in Cleygate Manor records as:

Freehold messuage, barn and garden 'next Cleygate' in the parish of Worplesdon and four crofts of land with two pieces of land enclosed thereto, containing 15 acres altogether, between the royal park of Henley on the west, land of John Bedell then Richard Bromfield on the north, the lane called Redstreet Lane on the south, land of Thomas then George Clifton on the east and north; rent 3s.

Formerly held by John Whitwell. [Harley roll]  
 Late held by William Hammond of Guildford. [Harley roll]  
 1547-49 Held by John Dawe. [Harley roll]  
 Subsequently held by Anthony Dawe. [Harley roll]  
 c.1580 John Dawe held a tenement and croft, rent 3s. [TS19/19]  
 by 1586 Anthony Dawe died, heriot one horse called a bay nag price 10s; property descended to Robert Dawe his son age 12.  
 1595 Held freehold by Robert Dawe, now of full age.  
 By 1599 Robert Dawe sold to Thomas West.  
 by 1603 Thomas West sold to Richard Bromfield.

Subsequently described as: Freehold messuage and 15 acres of land, rent 3s.

1620 rental: Held by Richard Broomfield (who also held Chapel Farm, Hill Inhams and Ashfield Lodge).  
 1620 Occupied by Thomas Smither.  
 1638 Richard Weller was recognised as the holder.  
 By 1645 Richard Weller died, bequeathed to Anthony Gadd, his brother in law.  
 [1649-64] Richard Weller died, descended to his sister Joan, wife of Anthony Gadd.  
 [1649-64] Joan Gadd died, descended to her relative Alice, wife of Thomas Stephens.  
 Early 1600s Apparently owned by John Gadd of Worplesdon, descended to his eldest son Anthony Gadd, blacksmith of Worplesdon, descended to Anthony's daughter Alice who married Thomas Stevens. [SHC 212/117/30] (Note that this conflicts with the entry above from the Cleygate court book. Anthony Gadd also owned Chapel Farm, but this account does not fit that property either. JVS)  
 1664 Still occupied by Thomas Smyther.  
 1668 rental: Held by Alice, wife of Thomas Stephens.  
 [in 1697] Described as "formerly Richard Broomfields, lately Thomas Stevens's".  
 15/10/1669 Thomas Stevens, yeoman of Ash, & Alice his wife, sold to William Christmas, husbandman of Worplesdon - messuage, barn, stables, garden, orchard and 12 acres of land, 3 acres of meadow & 5 acres of pasture. [SHC 212/117/30-31]  
 6/3/1675 William Christmas, yeoman of Worplesdon, died. His will bequeathed property to wife Anne for her life then to son William. [SHC 212/117/32]  
 1680 'Owned' by John Christmas (brother of William, deceased, and overseer of his will). [SHC 212/117/32, 37]  
 by 1682 Ann Christmas, widow of William, married Herman Rogers.  
 1682 rental: Held by Herman Rogers' wife.

- 1697 rental: Held by Ann the wife of Herman Rogers. Subsequently annotated 'William Christmas'.
- 1722 rental: Held by William Christmas (presumably the son - JVS).
- [1755-59] William Christmas died, descended to his son Philip Christmas.
- c.1780 "Philip Christmas's own house", entitled to cut two loads of peat from Cleygate peat moor. [TS19/40]
- 1780-83 Owned and occupied by Philip Christmas, rent £7. [land tax]
- [1782-86] Philip Christmas died, devised to Ann, wife of Thomas Chandler.
- 1784-91 Owned and occupied by Thomas Chandler. [land tax]
- 1790 rental: Held by Ann, wife of Thomas Chandler. [212/4/24]
- [by 1794] Thomas Chandler and Ann his wife sold to Goldfinch of Lombard Street.
- 1792-93 Owned by Henry Goldfinch, occupied by James Freakes, rent £10. [land tax]
- 1795-98 Owned by Henry Goldfinch, occupied by Mrs Freakes. [land tax]
- 1799-1808 Owned by Henry Goldfinch, occupied by Edward Chitty. [land tax]
- [by 1813] Henry Goldfinch sold to Edward Chitty. (1)
- 1809-31 Owned and occupied by Edward Chitty. [land tax]
- c.1818 Owned by Edward Chitty, occupied by George Beagley, entitled to cut two loads of peat from Cleygate peat moor. [TS19/40]
- 1825 rental. Held by Edward Chitty, age 90.
- 1830/31 Edward Chitty died, descended to eldest son Edward Chitty. (2)
- [1834-41] Edward Chitty, son of Edward Chitty, died.
- 1841 'Goldfinches Farm', owned and occupied by Edward Chitty (3) and John Chitty. 13-2-9. Plot 1082 (The Homestead) is two tenements and land (see below), plot 1083 is cottage and garden (see below). [tithe]
- [1872-74] Edward Chitty, miller of Guildford, died; will of 1870 gave property to his son John Chitty, but codicil of 1872 revoked and gave it to son Edward Chitty. (4)

Subsequently described in Cleygate Manor records as:

Freehold messuage and 15 acres at Willey Green, yearly rent 3s.

- by 1905 Apparently purchased by Lord Pirbright. [JVS]
- 1905 Described as 'late Stevens' (see 1669! - JVS).
- 5/10/1905 Lord Pirbright had died; Lady Pirbright was admitted.
- 13/9/1907 Lady Pirbright sold 'Chandlers Field', Willey Green to James Collins. [Alan Capell, title deeds to The Old Homestead]
- c.1910 Owned by James Collins of Bails Farm; land occupied by James Collins, The Homestead occupied by J Marshall & A Elliott, and Wrens Nest occupied by W Wakeford. 13 acres. (OS ref 482) [value Worplesdon 129-132]
- 1917 James Collins died. [PW140]
- 19/12/1928 Alice Frances Collins sold 'The Homestead' to James William Smith. [Alan Capell, title deeds]
- 1934 Chandler's Cottage owned and occupied by James Smith. [rate book]
- 1965 'Formerly Chandlers Cottage'. [Antiquities of Surrey, Surrey CC 1965]
- 2/10/1968 James William Smith died. [Alan Capell, title deeds]

**1082. The Homestead, Willey Green** (part of 'Old Homestead' smallholding, above).

- 1841 Occupied by James Begley/Beagley and George South, ag labs. [census]  
 1851 Occupied by James Horn, grocer and George South. [census]  
 1861 Occupied by James West, ag lab. [census]  
 1871 Occupied by Mary West, widow, and Allen West, ag lab. [census]  
 1881 Probably occupied by William Blake, farmer and market gardener of 14 acres, and James Upfold, ag lab. [census]  
 1891-1901 Occupied by Thomas Marshall, ag lab. [census]  
 c.1910 Owned by James Collins of Bails Farm, The Homestead occupied by J Marshall & A Elliott. [value Worplesdon 129-132]  
 1934 Chandler's Cottage owned and occupied by James Smith. [rate book]

**1083. Wren's Nest, Willey Green** (part of 'Old Homestead' smallholding, above).

- 1841 Cottage and garden, part of Goldfinches Farm. [tithe]  
 1841-51 Occupied by Charles Hepburn/Hebburn, ag lab. [census]  
 1861 Occupied by Richard Lunn, shoemaker. [census]  
 1871 Occupied by William Gosden, woodman. [census]  
 1891 Probably occupied by Joseph Oakshott, ag lab. [census]  
 1913 Wrens Nest Cottage, an old brick & tile bungalow with one bedroom, kitchen, pantry and washhouse, gross value £101. Owned by James Collins, occupied by W Wakeford. [value]  
 Wren's Nest was a small square wooden building in which the Wakefords lived. The front was used as a shop. [MSS6/30]  
 1910s Billy Wakeford first sold fish from his barrow. He used to push the barrow into Guildford to get the fish and sold it on the way back. Later he sold fruit from his barrow (see P13) and also rabbits which his son in law used to catch in the field behind the Homestead. He used to take the rabbit skins into Aldershot and sell them - he said he got more for the skins than the rabbits. [MSS6/27]  
 He used to hawk vegetables and oranges round the village from a costermonger's barrow - he was disabled and used the barrow as a walking aid! [MSS6/30, MSS6/31, MSS6/38]

**1149 - 1158. Passengers Farm, formerly Bush Ingham Farm.**

Mostly in Worplesdon, part in Ash (see 491-492 above). Also Island Farm [O.S. 955] Apparently *not* within the Manor of Cleygate. [TS19/37 page 227, court of 1841]. Also apparently *not* within the manor of Worplesdon. [SHC G97/6/26]. Probably within the manor of Wanborough. [JVS]

The farmhouse dates to the 14<sup>th</sup> century although the halled structure is mainly 17<sup>th</sup> century.

 1864 Occupied by William Hawkins, farmer. [Worplesdon PR]  
 1870 Sold by the trustees of the will of James Mangles Esq to Alexander McKibben Esq. 26 acres in total, 23 acres occupied by a Mr Luff. [MSS236/1]  
 1871 Occupied by Stephen Cawood, ag lab and Geo Penfold, carpenter. [census]  
 1881 Occupied by Thomas Croke, farmer of 25 acres. [census]

 2001 Put up for sale for £895,000. [Ian Mills]

A freehold tenement called Cobbetts Mead, rent one red rose.  
by 1528 John Slyfold died, descended to his son Thomas Slyfold.

A gate land called Whitehawes containing 2 acres, between land of Thomas Pullen on the east, land of John Baker on the south and the waste on the west and north.  
Before 1622 Thomas Pullen sold to Richard Haward.
